<i>Inappropriate decision to implement wearing of face coverings in school</i>	<b>All staff, pupils, visitors</b>	<b>H</b>	<p><b>During Periods of <u>National Rules</u></b> National guidance provided by the DfE/Public Health England is applied in relation to wearing of face coverings.</p> <p><u>Year 7 and above</u> Face coverings <b>are</b> worn by adults and pupils when moving around communal areas where social distancing is difficult to maintain, such as corridors, <b>and also in classrooms.</b></p> <p>Face coverings are also worn by all pupils when travelling on dedicated school transport</p> <p><u>Primary/Middle/Early Years/Special school (years 1 to 6)</u> Face coverings are worn by staff and visitors in situations where social distancing between adults is not possible (for example, when moving around in corridors and communal areas) <b>[children are not required to wear these]</b></p> <p><u>Risk Assessment</u> This risk assessment has been undertaken in light of national guidance in relation to the use of face covering in schools and with consideration to the following:</p> <ul style="list-style-type: none"> <li>• The ages of the young people within the establishment.</li> <li>• The layout of the building makes it difficult to maintain social distancing. <b>In our settings this is in all communal areas</b></li> </ul>		<p><i>[Perspex face visors/face shields are not an adequate substitution as they are unlikely to offer protection against aerosol transmission and therefore would need to be worn alongside a face covering].</i></p> <p><b>Out of School Settings</b></p> <p>Face coverings are to be used where it is a requirement of the indoor setting and where the activity is taking place in an area in which children in year 7 and above or staff are likely to come into contact with other members of the public and/or where social distancing cannot easily be maintained.</p>

			<ul style="list-style-type: none"> <li>• The inability to stagger timetables/breaks/lunch to reduce the flow of pupils in communal areas, such as busy corridors/stairwells etc, at times when there is significant pupil movement. This will include arrival and departure times.</li> <li>• Individual needs of pupils including their ability to cope with face coverings, apply them safely or to be able to communicate effectively-</li> </ul> <p>The control measures within the risk assessment are monitored regularly to ensure compliance and the risk assessment is kept under review and shared with staff.</p>		
Inappropriate use and disposal of face coverings	<p><b>All staff, pupils, visitors</b></p> <p>Potential exposure to live virus resulting in contracting Coronavirus.</p> <p>Inadvertent transmission to others.</p>	H	<p>Schools should have a process for removing face coverings when those who use face coverings arrive at school, and for when face coverings are worn at school. This process should be clearly communicated with staff and pupils with clear instructions on <a href="#">how to put on, remove, store and dispose of face coverings</a>. The process should <b>also</b> cover:</p> <ul style="list-style-type: none"> <li>• Where face coverings are to be used and by whom. All staff to wear face coverings in communal areas - these should be kept on within classrooms for year 7 and above where distancing cannot be maintained. All pupils from Year 3 upwards to wear face coverings when arriving and departing from school and in communal areas.</li> <li>• Ensuring the cleaning of hands before putting the face covering on and after taking the face covering off. Hand sanitiser is provided in classrooms and pupils are supervised in its use.</li> <li>• Safe storage in individual, sealable plastic bags between use.</li> <li>• Arrangements to prevent the use of coverings</li> </ul>		<p>School to maintain a supply of sealable plastic bags.</p> <p>See <a href="#">Guidance on arrangement for disposal of waste</a></p> <p><a href="#">World Health Organisation (WHO) - 'How to wear a fabric mask safely' video</a></p>

			<p><i>which are inappropriate, soiled, damp or damaged etc.</i></p> <ul style="list-style-type: none"> <li>• <i>Where <u>disposable</u> face coverings are worn these should be put into a bin bag in a non-recyclable bin (general waste) after use.</i></li> </ul>		
<p><i>Individuals not wearing a face covering</i></p>	<p><b><i>All staff, pupils, visitors</i></b></p> <p><i>Potential exposure to live virus resulting in contracting Coronavirus.</i></p> <p><i>Inadvertent transmission to others.</i></p>		<p><i>Parents should provide face coverings for pupils. If pupils who are required to wear a face covering forget or are unable to provide one, the school will provide a disposable or reusable face covering. This has been communicated to parents and carers.</i></p> <p><i>The establishment holds a stock of disposable face coverings for use by staff and pupils where needed.</i></p> <p><i>All visitors must wear face coverings where appropriate – office staff ensure compliance upon arrival at school.</i></p>		<p><i>Staff will already have access to face coverings of their choice for use in the community and these can be worn in school. If for any reason staff (or pupils if relevant) don't have access to a face covering, education settings should take steps to have a small contingency supply available to meet such needs. Each learning bubbles has its own supply of face coverings and suitable storage bags.</i></p> <p><i>Some individuals are exempt from wearing face coverings. For example people who cannot put on, wear or remove a face covering because of a physical or mental illness or impairment, or disability, or if you are speaking to or providing assistance to someone who relies on lip reading, clear sound or facial expression to communicate.[transparent face coverings can be worn in this circumstance although evidence surrounding effectiveness in transmission of Covid is limited] The same exemptions will apply in education settings, and teachers and other staff should be sensitive to those needs.</i></p>

Failure to communicate requirements for face coverings			<p>A risk assessment has been undertaken to determine when and where face coverings should be worn. The outcome of this assessment has been communicated to all staff, pupils <i>and parents</i> and measures are in place to monitor and, where necessary, enforce compliance.</p> <p>Communications have been approved by the senior management team and issued <i>as appropriate</i>.</p>		<p><i>The requirement for the wearing of face coverings within classrooms by pupils in Year 7 and above has been communicated to pupils and parents.</i></p> <p><i>Pupils (and parents)/staff have been reminded of the importance of ensuring face coverings are worn and handled correctly and that hand hygiene is practised before and after touching a face covering. This is supported by the class teacher.</i></p>
